# (2) LEARNING OUTCOMES

**Learning Outcomes** 

This course aims to familiarize students with the concept of empowerment for people suffering from chronic diseases and disabilities. Upon completion of the module, students will understand the different concepts of empowerment in health, be able to describe and analyze its dimensions, understand the factors that influence it and know the empowerment strategies applied to various vulnerable groups.

In particular, students are expected to acquire:

## Knowledge:

- To understand the different approaches (over time) to the involvement of users of health and social care services.
- To understand and analyze the factors that influence empowerment, as well as the interaction between them
- Understand and analyze the changes that must occur at multiple levels for empowerment to be considered successful.
- To reflect on the difficulty of measuring empowerment and evaluating intervention programs.
- They describe the basic principles of interdisciplinary research drawing knowledge from case studies in the health sector
- They describe the burden and social isolation of caregivers of elderly patients
- Understand psychosis and the difficulties it brings to the patient's life (social exclusion, stigma, vulnerability).
- They describe the interventions that can be made for the carer of the patient with psychosis (individually and in groups) in the community at the level of prevention, treatment and rehabilitation
- Describe how personal development groups can improve the health of vulnerable populations (according to the social determinants of health)
- Understand how community assessment can empower socially excluded population groups
- They recognize the contribution of Online counseling to the removal of Social Exclusion and to strengthening the inclusion and self-management of people with disabilities
- They describe the benefits of art in treating/rehabilitating/empowering disability

## Skills:

- Skills of diagnostic assessment of needs at individual, group, family, community level
- Skills to design and implement interventions to support the individual, group, family and community
- Skills evaluation of interventions and programs to support the individual, group, family, community

## Abilities:

- Ability to search, analyze and synthesize data and information
